Re: March 29, 1996 Federal Military Whistleblower Case of Homosexual Luring,
Stalking, Rape and Railroaded of 18 year-old Navy Sailor

Dear Senator Pryor,

This is the second letter to you, which was sent care of the staff member who handles your military and veterans' petitions and issues. As of this date, no one has received a response from your office on this ongoing eight year-old case involving cover-ups and continuing obstruction of justice. To refresh your memory, below is the underlying history:

Slightly more than eight years ago an unwary and inexperienced eighteen year-old Navy sailor from Arkansas, Steven R. Nary, was stalked while in San Francisco's Palladium – a youth disco. His stalker, fifty-three year-old Juan Jorge Pifarre, lured young Nary to his place, after an ATM detour, and under the pretext of partying with local girls.

While they were at Pifarre's apartment, which was in a remote little-known hilly area of San Francisco, Pifarre offered Nary a drink. Pifarre proceeded to get Nary intoxicated. (Besides being an inexperienced drinker, Nary is of Native American

ethnic heritage, and he shares that group's hereditary medical weakness when drinking alcohol.)

At that point, Pifarre, an experienced and documented homosexual predator, lured the sexually inexperienced and drunken youth into a coerced minor sex act. When young Nary woke up later that night, it was in the midst of an attempted rape by Pifarre. (Note: Piffare is creditably suspected of also using the date rape drug on Nary - as Pifarre had done this before with his other victims.)

Even though Nary had never been in a fight before, nevertheless, there was a fight then. Nary defended himself, even though Pifarre broke his hand. Nary left Pifarre unconscious when he fled to his ship, the USS Carl Vinson, which was ported fifteen miles away in Alameda County, California.

Local San Francisco police later came to the USS Carl Vinson to illegally interrogate and then illegally remove this sailor to the San Francisco jail. After 3½ years of abuse, denial of due process, denial of medical attention, denial of outside exercise, sunlight, and other human rights violations, Nary was illegally tried, in September of 1999 in a local San Francisco Criminal court, for Pifarre's death.

After extensive independent investigation, we later learned that the late Juan Pifarre was well connected to both the local powerful gay community and several San Francisco political figures. One of Pifarre's connections was with (then) local District Attorney Terence Hallinan. Hallinan was the D.A. who tried Nary in the local criminal court. Regarding the local San Francisco newspapers, Nary's pre-trial conviction in this venue bears out other Pifarre connections.

Since this young sailor's illegal trial and sentencing in the wrong venue, the cover-up has been ongoing. People who learn of this case, and who review the ample documentation, are shocked at the unnecessary waste, delays, and evasions. For example, even though Nary has been in jail for over eight years, no Federal judge has ever upheld the illegal San Francisco court sentence of 16 years-to-life. Yet Nary continues to languish in a California State Prison for what should have been a Naval disciplinary matter. And, according to a recently released Navy Judge Advocate document, the Navy had no intention of court martialing this young sailor as it was a "weak case" involving self-defense.

Have you thought about this un-addressed question: the cost to the American taxpayer and to the Navy of the waste of Steven Nary's board, benefits, and military training to defend this nation?

Have you thought about the cost to all of these agencies, and their personnel, that are involved in this egregious case just to cover-up for a dead, politically connected, illegal alien, supporter of terrorism (e.g., the Zona Rosa Massacre) and twice-documented homosexual predator:

- Navy Inspector General's Office.
- Navy Judge Advocate's Office.
- Navy Criminal Investigative Service/ Navy Investigative Service.
- Federal Bureau of Investigation.
- US Department of Justice/ Inspector General/ US Attorney's Office.
- US Navy's Pacific Fleet – in particular, the USS Carl Vinson.
- Secretary of Defense.
- SECNAV.
- US Marine Corps.
- Staffers the Armed Services and Judiciary Committees.
- The detailing of Naval personnel—air fare—motel—food –local transportation -- from their bases to testify in both the January 1997 Pretrial hearings and the San Francisco illegal Criminal Court trial in September of 1999.
- Navy Chaplain visits to the San Francisco Jail.
- Correspondence between concerned citizens and legal representatives.
- The Federal courts and the clerks, staff attorneys, Federal judges, who handled this case and all of its issues and violations of due process.

This case has needlessly cost American taxpayers an estimated \$25-\$30 million dollars. Below is the breakdown:

- 1) In this illegal case perpetrated by San Francisco's corrupt homosexual activists, the cost of the illegal trial, personnel involved and incarceration has cost American taxpayers an estimated five to ten million dollars because of all of the issues and expensive local, state and federal personnel and agencies involved.
- 2) But worst is the irrefutable fact that more than \$20 million dollars of U.S. taxpayer (i.e., HUD/ US Department of Housing & Urban Development/ Community Development) funds were spent on two gay pork barrel projects.
 - a) Specifically, \$10 million dollars was illegally spent on building a project at 1010 South Van Ness in San Francisco. The project was named after the above-mentioned and late Juan Pifarre: Pifarre Plaza.

Among the concealments in this RICO real estate deal, is that the promoters of the projects, business associates of Juan Jorge Pifarre, have set up a secret limited real estate project under the guise of a non-profit 501c-3 organization. After a number of years, these friends of Pifarre will own this \$10 million dollar project. We ask you: is private ownership of public housing appropriate for a non-profit group?

- b) The other gay graft project costing over \$10 million dollars is at 1800 Market, also in San Francisco. This project was named after Charles Holmes, a producer and purveyor of male prostitution videos that were

connected to the Palladium, a youth disco here in San Francisco, and the site on March 23, 1996, where the late Juan Pifarre, stalked, lured, and attempted to rape your constituent Steven Nary.

Over seven years of *pro bono* work has been done by the many people who are outraged by the ongoing cover-ups, obstructions of justice, and intimidation of witnesses in this case. We suggest that you contact Captain Vincent Averna, JAG (ret.) who is from McLean Virginia. He has lobbied the Navy for a full investigation of the cover-ups in this case. His phone number is 1-703-893-5525.

Since Nary is your constituent, and you are a member of the US Senate's Armed Service's Committee, we ask that you reply to us about what you will do to support a full investigation and help resolve the ongoing injustices in this case.

For your information, we enclose the Title 10 US Code § 1034 Federal Military Whistleblower letter to Mr. Gordon England, the Secretary of the Navy.

We suggest that you go to our website at www.amicusveritas.org to see the irrefutably documented chronology of the **Steven Nary, US Navy** case. Nary's case, including this letter, is on the World Wide Web and now the whole world is watching.
